TEXAS REGISTER

- The 11/10/06 proposed rules related to immunization consent and vaccination stamps (TAC 25, Chapter 97, Sections 97.91, 97.92, and 97.151-97.156) were **ADOPTED** on 06/01/07 and can be accessed at <http://www.sos.state.tx.us/texreg/index.shtml>
- As of 06/01/07 the 11/17/06 proposed changes to TAC 25, Chapter 97 (Reporting of Communicable Diseases) has not been formerly adopted according to the Texas Register publication as of 04/28/07.

TEXAS LEGISLATURE

- As of 06/04/07 there are 45 bills filed with the word “Infection” and 233 bills filed with the word “Disease”. Of those, 18 bills below have the potential to impact the practice of infection prevention and control in healthcare facilities. Of those 18, only those with activity are listed below – Please see previous 2007 reports at www.apicdfw.org (Professional Support → Government Affairs) if a bill you were tracking is not listed.
