8. Committee/SIG announcements:

Journal Club: Mary Fulton – Mary presented a 2014 AJIC study article by Steed, et al., "Reduction of nasal *Staphylococcus aureus* carriage in health care professionals by treatment with a nonantibiotic, alcoholbased nasal antiseptic". The study was conducted at an urban hospital center. Of the 20 healthcare workers who were positive for S. aureus carriage and were treated 3 times per day with the alcohol nasal antiseptic, a statistically significant reduction in S. aureus carriage (99% - mean) was noted. This may be an effective alternative to antibiotic treatment. Limitations included lack of repeat testing, and that this was a company-funded study.
